- It is strictly forbidden to sale any kind of product, to distribute brochures or to do
 promotion crews, advertising pets, skaters, etc., hand out advertising or
 merchandise that the organization deems unsuitable and that the exhibitor shows
 outside the exhibition area.
- It is forbidden to sublet the exhibition area given, partial or totally, in accordance with the provisions of section 12.1 of the Event Regulations.
- The exhibitor and assembly staff, are obliged to respect the spaces provided in number of square meters and height. Additionally, the maximum height allowed for building is up to 5.00 meters and the free design projects should be approved by the ANATO Organizing Committee and Corferias Assembly Division, with no exceptions. The designs that affects closer exhibitors will not be approve.
- The stand can only be disassembled after closure of the event, in the date and schedule established, being on Saturday, March 1st, 2025, from 08:00 to 18:00 hours.

For the above, I authorize the organizers of the event to:

- a) Do not authorize disassemble on a date and hours different from those agreed.
- **b)** Provide instructions to Corferias for not allow the exit of the elements from the stand on a different date to that established for it.

PENALTIES:

In case of breach any of the obligations set forth herein, exhibitors must pay to the organization, by way of penalty, a sum corresponding to five (5) SMLMV (statutory minimum wages) in Colombian pesos or its equivalent in dollars and the loss of the right allocation of space on the next Vitrina.

This payment must be staged before the Vitrina completion. In the case the payment is not processed, disassembly will not be allowed, carrying additional charges as a consequence.
