



COMMITMENT LETTER

Through this document, I ______ acting on behalf of itself or the company ______ who will be Exhibitor at the **XXXVII VITRINA TURISTICA – ANATO 2018,** would like to express:

That ______ in our condition as Exhibitor, we are forced to fulfill the "Exhibitors Regulation", of which we declare to know and accept completely as integral part of the Participation Contract and especially in:

- It is strictly forbidden to install in the stand sound equipment or loudspeakers that emits the maximum permissible decibels (40) that disturb visitors or other exhibitors. The breach of that will result the automatic cutting of the electricity in the stand.
- 2. It is strictly forbidden musical performs or folkloric groups (mariachis, jazz, percussion instruments, parades, etc.) celebration of cocktails and social events inside the exhibition areas during the Vitrina's celebration. Any activity must have prior authorization indicating all the features and it will be approved or rejected by the Vitrina's committee. Those presentations can be performed on the stage destined for that purpose, in the free zone located in Pavilion 4.
- **3.** It is forbidden to cook food like popcorn, sugar cotton, hot dogs, burgers, etc., besides is also forbidden to use gas appliance, coal, gasoline or any other fuel that represents danger and that give out smells or bother people inside the pavilions.
- 4. It is strictly forbidden to sale any kind of product, to distribute brochures or to do promotion crews, advertising pets, skaters, etc., hand out advertising or merchandise that the organization deems unsuitable and that the exhibitor shows outside the exhibition area.
- 5. It is forbidden to sublet the exhibition area given, partial or totally.
- 6. The exhibitor is obliged to respect the spaces provided in number of square meters, and height, which cannot exceed 5.00 meters, except in special cases, duly

considered and approved by both Corferias Technical Branch and the Organizing Committee.

 The stand can only be disassemble after closure of the event, in the date and schedule established, being on Saturday, February 24^{th,} 2018 from 8:00 am to 18:00.

For the above, I authorize the organizers of the event to:

a) Do not authorize disassemble on a date and hours different from those agreed.

b) Provide instructions to Corferias for not allow the exit of the elements from the stand on a different date to that established for it.

PENALTIES:

In case of breach any of the obligations set forth herein, exhibitors must pay to the organization, by way of penalty, a sum corresponding to five (5) SMLMV (statutory minimum wages) in Colombian pesos or its equivalent in dollars and the loss of the right allocation of space on the next Vitrina.

I have read and understood the contents herein, and I agree to comply the obligations set forth herein. In addition, I declare to accept and attend immediately and respectfully, the requests by the organizers during the development of the event related to compliance the obligations set forth herein and in the "**Exhibitors Regulation**"
